Biography

PUBLIC LAW

Jean-Pierre Hounieu, Doctor of Law, specialist in Public Law, co-manages the Public Law team

He acts in both an advisory and dispute resolution capacity, assisting major players in public procurement on matters ranging from the execution and performance of contracts to the enforcement of contractual or post-contractual guarantees, whether such contracts relate to public construction, general supplies and services or intellectual services.

Jean-Pierre also advises these entities in the context of complex legal structures having contractual issues relating to town planning, public land ownership, insurance and environmental issues.

He handles litigation and the defence of the interests of economic actors in the context of the enforcement of their liability before administrative and judicial courts. He also advises on appeals filed against town planning documents and permits or licences and against authorisations falling within the scope of the legislation governing facilities classified for environmental purposes.
