PISO 6 (European Property Investors Special Opportunities 6), a fund managed by Tristan Capital Partners and its partner Edmond de Rothschild Real Estate Investment Management (REIM), has just completed, through a dedicated investment vehicle, the acquisition of an ambitious logistics project in Dourges, in the Hauts-de-France region. Located at the heart of the Delta 3 multimodal platform, this site is a key lever in the Fund's real estate investment strategy, which focuses on innovation and sustainable performance.

With a surface area of 136,000 m², the Class A property complex is one of the largest logistics projects in the region. It will comprise 12 units, nearly half of which have already been reserved by a major player in the agri-food industry. This next-generation development will provide users with facilities integrated into the multimodal network, while incorporating renewable energy technologies.
